# 2018 OUTSTANDING SULAW AWARDS Call for Nominations

[Deadline for nominations: 27 July 2018]

The Silliman University Law Alumni Association, Inc. (SULAW) announces that it is now accepting nominations for the 2018 Outstanding SULAW Awards.

## RATIONALE

The ideals of excellence, integrity, probity, service to others and overall good character are expressions not just of Silliman University's motto ("Via, Veritas, Vita") but also particularly points to a practice of law or its application with a conscience.

The OUTSTANDING SU LAW AWARD, to be given during the annual General Assembly of the alumni association of the Silliman University College of Law, is designed to recognize these ideals in those who have gone through its hallways as living exemplars of the so-called "Silliman spirit" through the practice of "law with a conscience".

# NOMINATION PROCESS/GUIDELINES

- Any alumnus/alumna of the Silliman University College of Law may be nominated for the award, provided that the nominee meets the prescribed criteria as follows:
  - Excellent and distinguished performance in the field of specialization, area of responsibility, or chosen career – 30%
    - includes awards and other distinctions received, published researches, positions/titles attained and other significant professional output
  - Consistent and courageous pursuit of truth and committed to what is good, right, and just – 45%
    - Includes positive contributions to social and civic causes, volunteer work, leadership in community/civic organizations, active involvement in Silliman Law affairs
  - III. Exemplary lifestyle and conduct in private life, and in his/her relationship with family, friends, colleagues, and the general public – 25%
- Anyone from the Silliman law alumni or the Silliman Law academic community may submit a nomination, addressed to the incumbent SULAW President, at the following offices:
  - a. IBP Office of Negros Oriental at the Hall of Justice, Dumaguete City
  - Office of the Clerk of Court of the Regional Trial Court (OCC-RTC) of Negros Oriental at the Hall of Justice. Dumaguete City
  - e. College of Law, Villareal Hall, Silliman University, Dumaguete City

- Self-nominations will be accepted if accompanied, in addition to the prescribed requirements and documents, by a letter of endorsement/recommendation from at least one (1) other person stating why the nominee is eligible for the award.
- 4. Nominees should duly accomplish, in two (2) sets, the prescribed form(s) and documentary requirements on or before 27 July 2018. These documentary requirements include the curriculum vitae of the nominee together with certified true copies of any listed awards, accomplishments, credentials or other similar documents that would support the nomination in question. Photographs are also considered as supporting documents.
- Nominees must not be an incumbent member of the SULAW Board of Officers.
- Nominees must not have been previously convicted of any offense or found guilty in any administrative case or suspended for any lawful reason.
- The names of the nominees, once received, shall be published in the Silliman University website. Alumni of the Silliman College of Law are encouraged to submit any comment or information about the nominees concerned during the screening period.
- The nominees will be initially screened by the SULAW Board of Officers, then forwarded to the SULAW Awards Selection Committee for evaluation and selection. The members of this committee have been carefully selected for a wide representation.
