

**POLICY GUIDELINES:**

1. A 1.5% discount is given for full cash payment upon enrolment but not later than **June 10, 2019** for 1st sem & **November 12, 2019** for 2nd sem. This is subject to an annual review.
2. Withdrawal of enrolment for reasons other than sickness or physical injury should be done within the **first five days** from the start of classes to avail of full refund of downpayment (minus registration fee and service charge of P50.00). The insurance fee will also be charged if the student's name has already been submitted to the insurer. Students withdrawing after this period shall be charged as follows:
  - \* The amount paid or charged as downpayment - for withdrawals within the four weeks of the opening of classes.
  - \* 50% of tuition and fees - for withdrawals after four weeks of the opening of classes up to midterm
  - \* 100% of total fees - for withdrawals after midterm
