

# APPLICATION REQUIREMENTS Academic Year 2022-2023

Under Legal Education Board (LEB) Memorandum Circular No. 109, Series of 2022, law schools may implement their own reasonable admission policies for academic year 2022-2023. Since the conduct of an onsite admissions exam remains difficult due to the current covid-19 pandemic, entry to the Silliman University (S.U.) College of Law for the said school year shall be based on the requirements stated below.

The retention policy for incoming freshmen students is stated in the S.U. College of Law Guidebook for Students, a digital copy of which will be provided to every law student upon enrollment.

**General Requirements for Admission to the** *Juris Doctor* (with thesis) program - An entering law student must be a holder of a four-year Bachelor of Science or Arts or equivalent degree and must have earned at least 18 units in English, 6 units in Mathematics and 18 units in Social Science (History, Political Science, Economics, Philosophy, Psychology, Current Issues, etc.).

**Documentary and Other Requirements** – In addition to the general requirements stated above, to be considered for admission, applicants shall submit the following:

a. Transcript of Records (TOR) or informative copy of records issued by the school registrar if TOR is not yet available (scanned copy);

b. Statement of good moral character from the dean or professor of the school previously attended or from a prominent member of the community who is not related to the applicant (scanned copy);

c. 120 to 180-second smartphone video clip (4k resolution or higher is not allowed) of the applicant;

d. An original essay (saved in PDF format) written by the applicant of not more than 1,000 words. The essay shall be subject to a plagiarism check.

# **Interview Requirement**

The applicant shall make himself/herself available for interview by the S.U. College of Law Admissions Committee. The interview will be conducted virtually by way of Zoom. The applicant will be informed by email and text message at least three (3) days before the date and time of the interview.

# Application period

Application period is **May 1 to July 15, 2022**. Applicants will be informed of the status of their applications within seven (7) days from the date of interview. **Online enrollment for incoming freshmen** 

Upon admission to the S.U. College of Law, incoming freshmen may process their enrollment in accordance with the procedure set by the Registrar's Office.
